A Letter of Gratitude From Bishop Donald J. Kettler

My dear brothers and sisters in Christ,



Often I reflect on the great needs of this vast Missionary Diocese, an area spanning 409, 849 square miles to be exact. This year our needs have been particularly momentous. Beyond our core necessities, we are burdened with the additional cost of reorganization. In July, I reluctantly, but out of true need, asked for your additional contribution to help alleviate these substantial financial burdens. It is with a heart filled to overflowing with gratitude that I now thank you for responding to the desperate appeal sent out recently by this needy diocese, for answering my urgent plea, and for supporting us with your generous assistance. I am equally grateful for the many promises of prayers and offers of continued and future assistance. While I am at a loss for words to express my thanks to you, I am confident that God will thank you in an infinitely better way than I can. I promise you, and I assure you, of daily remembrances in my Masses and prayers.

I am now in my 8th year as Bishop of the Diocese of Fairbanks. Many challenges face me, as I strive to provide support to our 46 parishes, only eight of which are financially self-sustaining. At the same time, we face the challenge of declining numbers of priests to minister across rural Alaska. You may recall that our onetime number of 47 priests, just twenty years ago, has now declined to 19. Many of our priests minister to six or more villages, traveling constantly to bring the Mass and the sacraments to our Eskimo people living along the Bering Sea Coast and in the Yukon-Kuskokwim Delta and to our Indian people in the Interior. The cost of travel continues to be a necessary burden within our budget.

We could not carry out our apostolic mission without you. We recognize that, without God's help and your prayerful and financial assistance, our efforts would be in vain. It is because of you that we keep repeating: "*Some give by going to the missions. Some go by giving to the missions. Without both, there would be no missions.*"

Besides enabling me to express my gratitude to you, this letter affords me also an opportunity to inform you of how we distribute your donations and to provide you an update on this Missionary Diocese. The major part of your donation is allocated to operational expenses and is used to cover expenses incurred by our various Bush missions. In addition to outright cash donations, annuities, wills, bequests, stock gifts and life insurance policies are some of the special ways you can help us meet the call to serve the people living and ministering here in Northern Alaska. Thanks to such generous benefactors as you, over the past 20 years, we have been able to build our Annuity and Endowment Fund. During these same years, the earnings have helped us operate and maintain our mission programs. For almost 50 years now, generous folks such as you have donated to our work through the Alaskan Shepherd Fundraising Program. We are grateful beyond words.

Please take a moment and look over the ways of giving enclosed with this letter. In an effort to give you some alternatives to your past practice of gift-giving, we have prepared this list of diverse opportunities to support our apostolic ministries. It is simply our attempt at potentially simplifying the way your donations may be gifted to the Catholic Bishop of Northern Alaska (legal corporate name.) If there are any options, which interest you, or if you have any questions, please drop us a line and we will be happy to have a member of our staff contact you to answer your questions.

In this era of financial uncertainty, I am aware of the multitude of financial challenges and obligations on your budgeting plate. It is, therefore, that I am especially grateful to you for your support and interest in our apostolic works here in this cold corner of the Lord's Vineyard.

I look forward to continuing this relationship with you for many years to come. May all your days be filled with all the blessings you so richly deserve. May the Almighty bless and lead us all.

Outright Gift: These gifts take the form of cash, common stocks, securities, real estate and personal property.

Bequest: Through a Last Will and Testament or Trust, donors can bequeath a specific amount of money, stocks or mutual funds, and real or personal property, (a percentage of the remainder of their estate.)

Charitable Lead Trust: Through cash, common stock or real estate, this gift operates in the opposite manner of a remainder trust, in that current income for a specific period of the trust is used by the Catholic Bishop of Northern Alaska. After a specified period of time, the corpus is returned to the donor or beneficiary.

Charitable Gift Annuities: This type of annuity provides fixed income for life of one or two people. Interest rates are based on the annuitants' age and payments are available on an annual, semi-annual, quarterly or monthly basis. The annuity can be funded with cash, common stock, or securities. Upon the death of the annuitant or last surviving annuitant, the remaining asset will be retained by the Catholic Bishop of Northern Alaska.

Deferred Gift Annuities: Similar to an immediate payment annuity except that the payments begin at a future date determined by the donor at the time of the gift.

Charitable Remainder Annuity or Unitrust: Like the gift annuity, the donor receives a life-time income and may receive an immediate charitable tax deduction. It is usually funded with real estate, common stock, securities or cash.

Charitable Insurance Policy: You may obtain an insurance policy with the Catholic Bishop of Northern Alaska as the beneficiary and owner of the policy. You may also be able to obtain a tax deduction for the cost. Please call us or any life insurance agent to discuss this option.

Stock: One opportunity for assisting with our mission work here in northern Alaska is to make a gift of stock to the **Catholic Bishop of Northern Alaska (CBNA)**, the legal name for the Diocese of Fairbanks.

Pension Protection Act Extended IRA Charitable Rollover Extension

On October 3rd, 2008, President Bush signed legislation (Public Law 110-343), which includes an extension of the IRA Charitable Rollover originally enacted as part of the Pension Protection Act of 2006. The extension is retroactive, applying to distributions made throughout both the 2008 and 2009 tax years. The extension will allow individuals 70 1/2 and older to donate up to \$100,000 from their IRAs to charities tax-free. The National Committee on Planned Giving (NCPG) staff and members across the country worked with federal lawmakers throughout the year to advocate for this extension.

If you would like to make a tax deductible charitable distribution from your IRA to the Catholic Bishop of Northern Alaska under these rules, you may use the following instructions to request a transfer from your plan administrator.

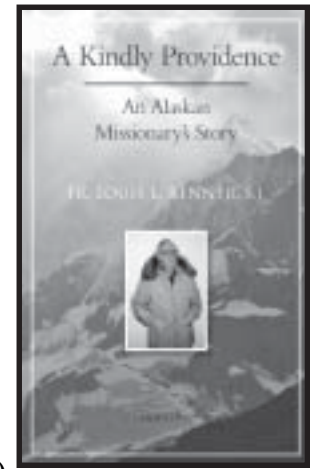

Reagan....And a challenge it proved to be!....the very summit of old Oz himself....when in walks Father General....‘And Gaawd bless you too, Faawther!’stickdance....the slap of a slimy fishtail in my face....got down to minus 76....Yet another case of mixing the useful with the pleasant....Up comes the stern. And, up comes—the kid’s breakfast....end of a wonderful 2,327-mile trip!...But then I thought to myself, ‘Oh, what the hell! Why not?’*Koyukon Athabaskan Dictionary*....not a ‘natural’ for prison ministry....a grizzly parading her two cubs past our camp....left a big hole in my personal life....the Dempster Highway....little foxes running around on my tent platform....‘The Great and Sacred Jubilee Year of Our Lord 2000’Vice President of the United States, The Honorable Richard B. Cheney....proved to be a fairly accurate prophecy...*ALASKANA CATHOLICA*.... the same kindly Providence.”

A Kindly Providence is a comprehensive and richly illustrated autobiography. Fr. Louis L. Renner, S.J., a dedicated missionary in Alaska for 40 years, tells a compelling story of a full and fascinating life of service to the people and the Church in northern Alaska, a great land of natural beauties, challenging elements, and vast wilderness regions.

Beautifully, Fr. Renner interweaves the everyday lives of the people and the Church as he experienced them first hand as a scholar, a teacher, a “bush missionary,” and ever the Jesuit priest. In the course of his long years in Alaska, among other ministries, he taught German and Latin at the University of Alaska Fairbanks, edited the Catholic newsletter *The Alaskan Shepherd*, and had the pastoral care of two different Indian villages on the middle Yukon River. For his scholarly writings, Tony Knowles, the governor of Alaska presented him with the “2002 Governor’s Award for Friend of the Humanities.”

A Kindly Providence, in softcover, spans 583 pages including some 80 illustrations.



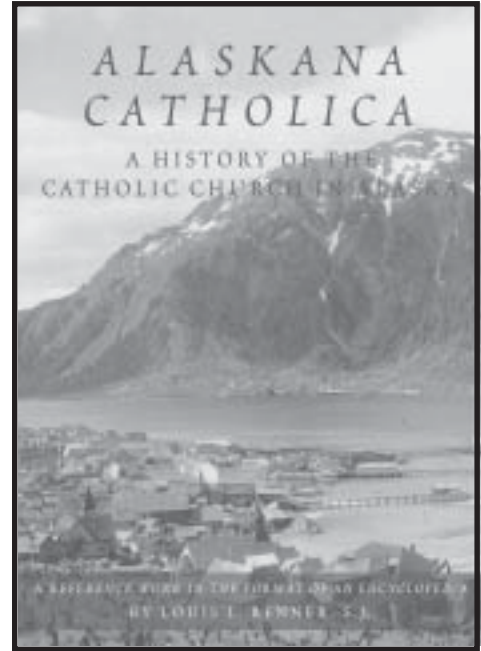
